Dear Father,

Bishop German Orrego has asked me to invite you to attend the 2015 Provincial Synod of the Anglican Catholic Church and associated events, which will meet at the Georgia Center for Continuing Education and at Saint Stephen's Church in Athens, Georgia, during the week of October 25th-31st. You are invited to attend as a clerical delegate for the Missionary Diocese of New Granada with Bishop German. By this letter I request any U.S. consular officials to assist you in obtaining the visa necessary for this travel. As I will myself be in Colombia in early July, I will deliver this invitation to you personally and by hand.

The Anglican Catholic Church will cover the cost of your registration fee for the Synod and of some meals not covered by the registration fee. While we may be able to provide some further assistance, in general you will be responsible for the cost of travel to and within the United States and for hotels and meals while here.

The Georgia Center contains a hotel and is located on the University of Georgia campus in Athens. The university's website contains details of this facility, but we will make reservations for you once a visa is in hand. Saint Stephen's address is 800 Timothy Road; Athens, GA; 30606. Some meetings and the principal liturgies of the Synod will be held at the church, while business sessions and housing will be at the Georgia Center. We will provide you any needed transportation between the Georgia Center and the church.

The Provincial Secretary, Mrs. Deborah Weaver, will be glad to assist you with information. This year we are requiring overseas visitors to obtain medical insurance to cover any costs that might arise while they are in the United States. Mrs. Weaver has located relatively inexpensive coverage and will assist you in obtaining that, again, once your visa is in hand. At that time Bishop German can provide you with Mrs. Weaver's contact information, or I can do so at the e-mail address above.

Any U.S. consular official is welcome to contact me or my office staff at the above telephone number and address if they have any questions concerning this invitation.
