Re: Response to No. 4048 / Request for Cancellation of Up-coming Dog Parade Event

Dear Inspector,

In response to the event to raise awareness about the issue of the need for proper care and attention for our beloved pets, this is to request the up-coming Dog Parade be cancelled. Due to the decision of your supervisor, Carlos Augusto Hincapie Franco, in which my access to further service and protection has been restricted, I cannot under the current circumstance participate and so respectfully decline the invitation. I view the decision as adding insult to an already contentious situation, and for this reason the event should not go forward at this time as it demonstrates insensitivity and arrogance. According to your statement the event is the result of the needless death of my beloved pet last July, yet as the maneuvers by your boss are in violation of the right of all foreign residents to authentic communication when unable to defend themselves in Spanish, the restriction is provocative and offensive. Moreover, as it is a deliberate attempt to frustrate and so derail my attempt to obtain equal protection, the fact the event has not been cancelled suggests the real motive behind the event is to transform my pet's tragedy into a platform favoring the leash restriction and so drawing away public attention away from the lack of enforcement by the Police of the restriction. As the maneuvers appear to have been undertaken with an ulterior motive in mind, so I oppose the event under the current circumstances. I ask the event be cancelled until the meaningful issues related to my pet's death and the surrounding issues affecting the rights of all foreign residents are resolved. Therefore I do not wish for the incident involving my pet's needless death to be associated with or used in promoting the up-coming event. Then it is my hope the event will be cancelled, yet if not then I ask that my wishes for my pet's death not to be associated with it, to be respected.
